Extract of Memorandum of Agreement
(POWERGRID National Bipartite Committee)

0.5.4 : Employment to one dependent of each workman who is permanently disabled or dies as a result of accident while on duty, will continue to be provided as at present. Dependent for this purpose will mean spouse of the employee, his/her son or daughter or legally adopted son/daughter.
