The information sought is given below:

- 1) Yes, 132 kV, 220kV, 400kV and 765kV.
- During the last five years, a large number of orders for Gas Insulated Switchgear (GIS) have been placed and the details of which are available on POWERGRID's website www.powergridindia.com The information sought is voluminous in nature and compilation of the same would disproportionately divert resources of the public authority.

Further, in the event you desire to inspect any specific documents/records, you can also do so by visiting our Corporate Office on any working day with prior intimation. You are also advised to intimate us about your proposed date & time of visit at least two weeks in advance and the specific records you wish to inspect, so that documents are kept ready for inspection. It may please be noted, in the event you desire to avail photocopy of any concerned document, the same shall be made available on payment of applicable charges.

- The GIS is being procured from manufacturers across the globe based on norms specified for qualification. However, the manufacturers ALSTOM, ABB, Siemens, Hyosung, NHVS, SIAN and Pinggao has supplied/is supplying the GIS to POWERGRID.
