## ORDER

## **Grounds of Appeal**

The Appellate Authority, Corporate Centre, POWERGRID has received an appeal dated Nil (received on 23<sup>rd</sup> July, 2014) from Shri Dhirendra Sharma, under RTI Act, 2005. An application dated 26<sup>th</sup> April, 2014 was filed by the Applicant with the CPIO, Corporate Centre under RTI Act, 2005 to obtain certain information regarding the Allotment of POWERGRID's Quarters at Gurgaon, Haryana.

On receipt of the appeal, comments/ opinion of the CPIO, Corporate Centre and the concerned departments were heard and relevant papers were perused. CPIO stated that point-wise reply to the queries, as received from the concerned departments, was provided to the applicant vide our letter dated 18<sup>th</sup> June, 2014.

CPIO stated the following in respect of the points raised by the Appellant in his appeal letter:

A comprehensive list comprising of (i) name of employees (ii) designation (iii) employee no (iv) flat no and (v) date of allotment, etc., has already been furnished. The concerned department stated that as and when application is received, it is appended in the waiting list and after allotment the date of application is not part of the recorded data. As the date of application for allotment of quarters is not maintained in the computerized list, date of application received by the employee has not been provided. However, in the event, applicant desire to have any specific application date, same can be provided.

With regard to list of out of turn quota, concerned department re-iterated that there were no out of turn allotment of quarters. However, the applicant has now seeking the list of allotments under GM quota based on the reply already furnished. Since, this being new query in appeal, which cannot be admitted at this stage. CPIO further stated that since the information sought pertaining for a period of 10 years, while furnishing the reply, the applicant was also offered for inspection of documents related with allotments of quarters.

Concerned department informed that in the event applicant desires to inspect any specific document/record, he can do so by visiting our Corporate Office on any working day with prior intimation.

## Decision

On going through the appeal and explanation given by the CPIO and the concerned department, the information/ documents sought by the appellant has already been provided by the CPIO. Further, it is understood that CPIO had already advised the appellant for inspection of information/record. Therefore, the appellant is advised to coordinate with the CPIO for inspection of document as stated by the CPIO if he desires so. As such no further action is envisaged on the subject matter by this office.

The appeal is accordingly disposed off.
