1.	How many villages are in India which are un-electrified.	This point is transferred to the PIO, Rural Electrification Corporation Ltd. (REC) under Section 6 (3) of RTI Act, 2005 for providing information directly to you.
2.	How an electrified village has been defined according to Ministry of Power.	As per New Definition (2004-05), "A village would be declared as electrified if: (i) Basic infrastructure such as distribution transformer and distribution lines are provided in the inhabited locality as well as the dalit basti/hamlet where it exists. (For electrification through Non-Conventional Energy Sources a distribution transformer may not be necessary). (ii) Electricity is provided to public places like schools, panchayat offices, health centres, dispensaries, community centres etc. and (iii) The number of households electrified should be at least 10% of the total number of households in the village."
3.	How many thermal, hydel, nuclear, tidal, solar, geo thermal power plants are operational in India. Provide details such as the installed capacity, power generated (for 2013-14), production cost involved per unit from all these forms of power generation.	This point is transferred to the CPIO & Under Secretary (P&P), Ministry of Power under Section 6 (3) of RTI Act, 2005 for providing information directly to you.

4.	Provide the details of transmission and distribution losses.	This point is transferred to the CPIO & Under Secretary (APDRP), Ministry of Power under Section 6 (3) of RTI Act, 2005 for providing information directly to you.
5.	Provide the details of central grid such as where is it located, how many sub-stations come under this grid.	This point is transferred to the CPIO & Under Secretary (Trans), Ministry of Power under Section 6 (3) of RTI Act, 2005 for providing information directly to you.
