Dear Mr. Singh,

This has reference to your letter dated 12th May, 2014 seeking information under RTI Act, 2005.

Out of 20 employees, 6 employees namely Shri Paramjeet Singh Chahal, the then DGM, Shri P.K. Agarwal, the then Manager, Shri Hans Raj Sapaiya, Sr. Vigilance officer, Shri O.S. Randhawa, DGM and Sh. S.N. Pandey (wrongly mentioned as S.P. Pandey), Dy. Manager (Vigilance) are from Vigilance Department. Shri Rajesh Verma, former CVO, REC also visited to NR-I/CC and Mainpuri site to investigate the matter entrusted to him by the Ministry of Power as CVO, REC.

It may be informed that CVC vide its Circular No. 26/07/010 dated 15.07.2010, has intimated that the Central Information Commission vide his decision dated 16.09.2009 had decided that movement/tour details and TA Bills of the officers/officials working in Vigilance Departments of the Govt. Organization should not be disclosed, keeping in view the provisions contained under Section 8(1)(g) of the RTI Act. Thus, the information sought about the tour details/tour claims of Vigilance officials namely Shri Paramjeet Singh Chahal, the then DGM, Shri P.K. Agarwal, the then Manager, Shri Hans Raj Sapaiya, Sr.VO, Shri O.S. Randhawa, DGM, Sh. S.N. Pandey Dy.Manager (Vigilance) and Shri Rajesh Verma, CVO, REC are exempted under Section 8(1) (g) of Chapter-II of RTI Act, 2005.

However, the expenditure incurred in respect of Sh. K. Raghuram, Sh. K. S. Murthy and Sh. Ashok Rajan is attached at Annex-I.
