

- 1) Whether the rules and regulations framed by Ministry of Personnel and Training for promotions of Govt. of India employees are being implemented in Power Grid Corp. of India Ltd and all its subsidiaries?
- 2) IF YES, whether proper representation is being given to SC/ST/Women/Minorities in Constitution of Departmental Promotion Committees?
- 3) The copy the Recruitment Rules/ Roaster Point Register including promotion rules for the posts of E2A, E3 and E4 posts may kindly be provided. ?
- 4) How many meetings of Departmental Promotion Committees were conducted for promotion from E2A to E3 and E3toE4 officers between 2012 to 2014? How many officers were considered for promotion in each category and how many officers were not found fit for promotion by departmental promotion committees in each category. The year wise details may be provided.
- 5) Whether any SC/ST candidate was also not found fit for promotion from E2A to E3 and E3 to E4 officers. The reasons for rejection of promotion may be provided along with the copies of Agendas and Minutes of Departmental Promotion Committees Conducted by PGCIL between 2012 to 2014 for promotion of all officers from E2A to E3 and E3 to E4.
