Dear Mr. Bajaj,

This has reference to your letter dated 9th July, 2014 for providing information under RTI Act, 2005. The information sought is given below:

- 1) Information sought pertains to Third Party under RTI Act which may be shared after affirmation from third party. The Assessment Reports contain details about the party that are held by POWERGRID in a fiduciary relationship. The disclosure of the details of the Assessment Reports regarding capability may harm the competitive position of the party. Therefore, the same cannot be provided without the consent of the concerned party.

Further, it may be noted that the information sought is voluminous in nature and gathering of this information would disproportionately divert resources of the Public Authority. As such, at the first instance, you are advised to specify the name of any those party whose Assessment Report is requested, disclosure of which will serve the larger public interest, so that consent can be sought from them.

- 2) POWERGRID is executing various projects / lines / packages all over the country having worth over than 1 Lakh Crore. Review of these projects are being carried out at various levels in line with WPPP (Works & Procurement Policy & Procedures) depending of the progress/ requirement of the projects. The information desired by your letter does not indicate any specific project & time period and cover the whole Corporation's scope of work. The gathering of this information would disproportionately divert the resources of the Public Authority and moreover may not serve any larger public purpose. Accordingly, you are advised to specify the specific minutes of meeting, so that same can be furnished to you.
