
The information sought is given below:

- There is no cut-off mark for final selection. Only, candidate who qualifies in interview, their marks secured in GATE, Group discussion, & Interview are combined in different weightages to calculate the final score (Please refer to our detailed advertisement in website) and they are empanelled. Offer of appointment is issued to empanelled candidates in order of category wise merit.
- Category-wise cut off marks in GATE 2014 (normalized marks out of 100) for being shortlisted for GD and interview has been declared in the candidate login of each applicant.
