1. Since 2012, why there was no CVC's Audit was done in spite of the fact that there were more than Rs 2/ Crores worth contract works were carried out by the Corporation, in each year
2. AS PER THE CVC GUIDELINES IN THE TRAVELLING ALLOWANCE CASES, WHERE PERSONAL INTEGRITY IS COMPROMISED THE HIGHEST MAJOR PENALTY IS TO BE AWARDED WITH RESPECT TO Smt. KALAI SELVI, EVEN THOUGH RS 2,00,000 IS APPROX UNDUELY WITH DRAWN FROM THE CORPORATION BY SUBMITTING FORGED BILLS & DOCUMENTS, HOW, THE LEAST MAJOR PENALTY WAS ACCEPTED BY THE CVC & THE CORPORATION? IT IS ALSO LEARNT THAT SUCH A PERSON IS BEING POSTED AT HER OWN NATIVE DIST, AND BEING MADE AS THE IN-CHARGE OF SALEM SUB-STATION BY THE REGIONAL HEAD. WHY THIS REWARD FOR A CORRUPT OFFICIAL IN THIS REGION? IS THERE SCARCITY FOR HONEST OFFICIALS IN THIS REGION? PLEASE PROVIDE ME THE COPY OF THE NOTE.
3. MAJOR PENALTY WAS RECOMONDED IN THE YEAR 2012 BY THE CVC AGAINST POWER GRID CORPORATION OF INDIA LIMITED's Shri DG SOHONY, THE THEN EXECUTIVE DIRECTOR, SRTS-II & 5 others .PLEASE PROVIDE ME THE COPY OF THE PUNISHMENT ORDERS.
4. A REPORT WAS SUBMITTED BY POWER GRID CORPORATION OF INDIA LIMITED TO THE CENTRAL VIGILANCE COMMISSION FOR INVESTIGATION APPROVAL IN THE 765 KV TUTICORIN-SALEM PART -1 TO THE TUNE OF Rs. 5/ CRORES & PART -2 TO THE TUNE OF Rs.7/- CRORES, IS MENTIONED . PLEASE PROVIDE ME THE COPY OF THE INVESTIGATION REPORT. AS PER PDPI WITH IN 3 MONTHS, REPORT SHOULD BE PUBLISHED IN THE WEB SITE OF CVC. PLEASE ALSO PROVIDE ME THE REASON FOR NOT SHOWING IN THE WEB SITE FOR THE ABNORMAL DELAY IN SHOWING IN THE MONTHLY REPORTS PLEASE PROVIDE ME THE COPY OF THE REPORT.
