- 1) Candidates who have been issued offer of appointment have been informed through email as well as SMS. All applicants are able to see their status at the Candidate Login.
- 2) The recruitment process for the subject post is still under progress as the selected candidates are yet to join. A list of all the candidates who have been selected and have joined at their respective joining locations shall be published after completion of the recruitment process.
- 3) Candidates who failed to qualify in the interview have been informed through their respective candidate login. The qualifying criteria in interview has been declared in the detailed Advt. No. CC/01/2014 dated 07.01.2014.
- 4) As per declarations given by the candidates at the time of interview, none of the selected candidates have relatives working in POWERGRID as employee/ Director/ Managing Director.
- 5) No departmental candidate has been shortlisted or selected.
- 6) The requested documents are available in the related files and can be inspected at our office on any working day with prior intimation of at least 30 days.
- 7) One complaint was received regarding the recruitment of dependent of a Director of the company. However, it is to inform that none of the candidates interviewed/ selected are having any direct relationship with any Directors/Employees of POWERGRID.
