As per section 7(6) of the RTI Act 2005, Notwithstanding anything contained in subsection (5), the person making request for the information shall be provided the information free of charge where a public authority fails to comply with the time limits specified in sub-section (1).

As per section 19(5) of the RTI Act 2005, In any appeal proceedings, the onus to prove that a denial of a request was justified shall be on the Central Public Information Officer or State Public Information Officer, as the case may be, who denied the request
