2. Further, it is stated that the subject matter of your application also pertains to all State Government/UT Admn. In this regard, reference to DOPT's O.M no. 10/2/2008-IR dated 12/06/2008 may be taken, wherein it has been clearly clarified in Para 3(iv) that if a person makes an application to a public authority for some information which is the concern of a public authority under any State Government or the Union Territory Administration, the Central Public Information Officer (CPIO) of the public authority receiving the application should inform the applicant that the information may be had from the concerned State Government/UT Administration. Application, in such a case, need not be transferred to the any State Government/UT Admn.

3. Accordingly, it would not be appropriate to transfer your application under Section 6(3) of the RTI Act, 2005 to PIO of any State Govt./UT Admn. Hence, you are also advised to directly approach to the PIO concerned in the State Government/UT Admn. alongwith requisite fee, as may be prescribed by them.

Dear Sir,

Please supply us following information relating to Number of fatal electrocution accidents or those occurred during use of electricity or working on electrical equipment, year wise, state wise, since 01.01.2012 till 30.06.2014:

1. How many persons are killed in electrical accidents, or those occurred during use of electricity or working on electrical equipment?
 2. What type of accident caused these fatalities for example Coming in contact with electricity, electrical burn, fall from height after getting electric shock, or any other format in which Ministry had made the statistics;
 3. How many employees including persons employed on contract are killed during transmission/ distribution of electrical power. Give Transmission Company/ Power distribution company wise, year wise fatalities;
 4. How many persons were killed, which were not associated while working with power utilities, like killed when live power fell on the bus or working any where else;
- In which Power Utility Company, the owner had setup a sound and scientific Safety Management system, which includes Establishing methodology for Internal and External Safety Audit of Safety Management System, ~~as required under section 4 (4) of the Central Electricity Authority (Safety requirements for construction, operation and maintenance of Electrical Plants and Electric Lines) Regulations, 2011?~~ Give - Gpy.
