- 9. Total 36 Nos of fatal accidents have occurred during construction since 01.01.2013 to 30.06.2014. (Details attached as Annex-I)
- 10. The details regarding fatal accidents, have been provided in Section-II, Instruction to bidders (ITB) and Section-III, Bid Data Sheets (BDS), Volume-I of the Bidding documents for (Supply-cum-Installation) packages under domestic funding. Further, it may be noted that the Bidding documents are available on POWERGIDs website www.powergridindia.com.
- 11. Provisions for such rules, as amended from time to time, were available in the Bidding Documents for the packages for which bids opened after January 2012.
- 12. A large number of contracts have been awarded during the last two years and the information sought is available in the respective contract files. Accordingly, gathering of the information would disproportionately divert the resources of the public authority. As such the information may be provided, if you specify the name of the contract.
