This has reference to your RTI request dated 19<sup>th</sup> August 2014 addressed to CPIO NRTS-I seeking information under RTI Act, 2005.



This has reference to your letter No. 03/94/2013 - PG dtd. 14.11.2013 on the above subject, regarding providing employment on compassionate grounds to Smt. Khushboo Goswami, wife of Late Shri Amit Goswami, ex - employee POWERGRID.

In this regard it is to inform that Late Sh. Amit Goswami, Emp. No. 11463, was working as Assitant Finance Gr. IV in Northern Region-I in POWERGRID. Sh. Goswami passed away on 27.08.2013 due to illness.

The relevant provision in POWERGRID states that, "POWERGRID will provide employment to one of dependents of each workman who is permanently disabled or dies as a result of accident while on duty."

Consequently, the instant case does not fall under the purview of extant provision in the Corporation.

Therefore, we are not in a position to consider the request of Smt. Khushboo Goswami.
