Dear Sir

I Mandeep Tyagi s/o Shri Dharam Vir Tyagi filed a RTI on 08.10.2014 vide PO No 23F260032 and same was sent by Registered Post No A RH043011178IN. However, CPIO has discriminated and wrongly denied the sought Information under clause 8.1(j)

- Whereas on 28.06.2013 your office CPIO supplied similar information related to the whereabouts /details of Power Grid Corporation of India employees on specific dates vide its letter No C/CP/RTI/2013/06. Therefore, it is wrong on the part of CPIO to discriminate and deny similar information this time. (Enclosed copy letter No C/CP/RTI/2013/06)
- Also, enclosing PowerGrid Corporation of India certificates dated 15.10.2000, 19.05.2000 and 20.09.2001 in support of my RTI Application dated 08.10.2014. Certificate copies have been self-attested by Assistant Registrar Cooperative Societies Faridabad, Govt of Haryana. That it is self-explanatory from the Contents of said certificates that PowerGrid Corporation of India's Letterhead, Stamp and signatures of authorized signatories have been used to certify that its permanent employees are eligible to get membership in a Cooperative Society in State of Haryana.

Hence ,in view of the fact that my RTI application dated 08.10.2014 is in context of the above referred certificates issued by PowerGrid Corporation of India Limited and submitted before Registrar Cooperative Societies, Haryana, therefore CPIO has wrongly denied the information under clause 8.1(j)

Therefore for the sake of justice you are once again requested to supply relevant information:-



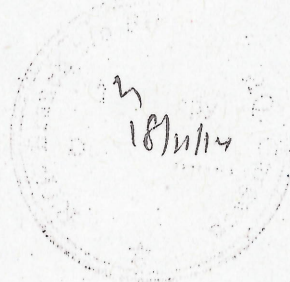

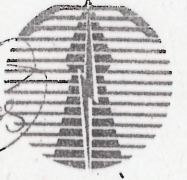
