3.	Information sought	There is no minimum percentage of marks prescribed by Public Enterprises Selection Board (PESB) at qualifying degree level for appointment of Directors to the Boards of PSUs. Please provide a copy of the document/ study that justified this justifies this practice that requires that a Junior/ Middle/ Senior level manager of technocrat must have 60% marks at the qualifying degree examination

		but a Director is not required to have 60% marks.
