Letter sent to SO(RE) for issuance). Finding no way out he has filed first appeal no POWER/A/2014/60043. But no success till date. I have communicated with EE kuakhia but he neglects the

In another complaint no MPOWR/E/2014/00225 dated 10.06.2014 regarding electrification of village upula, po-bantala of jajpur district the answer provided 2509/3804 dated 24.06.2014 is not satisfactory. I have the following questions.

1. Provide the following details of RAMPA panchayat and BANTALA panchayat of jajpur district.

(a) Give the detailed project report, number of BPL family covered under RGGVY, no of BPL are yet to connect. Give reason.

(b) The no of poles, wire, LED lamp, meter & other material specification, amount, cost of the items, date of enersization, date of Completion, design, drawing, layout and PERT/CPM work study report etc.

(c)Provide the Xerox copy of the conformation report signed by each customer after energisation.

2.Provide the detailed mailing address, email, mobile no, phone no of contractors which are involved/currently involved in RGGVY projects in jajpur district in project wise.

3. Provide the latest guidelines, circular about RGGVY. - was sales

4. Provide the detail designation, name, phone no, mobile no, e mail id, of each and every officer and staff of PGCIL including the zonal offices and the project offices.

5. Reply provided by REC both RTI and grievance reply state that the project of jajpur district was sanctioned under RGGVY in xii plan on 31-12-2013 and the scheduled completion period is 24 months from the date of award. My questions are:

a. before 31-12-2013 PGCIL was doing the same project in jajpur district for the same village upula and rampa. On which project and which plan PGCIL was doing so.

b. if this villages are covered in xi plan, then why the need of xii plan. c. why all the BPL families are not covered under this scheme and the people wait for a few years to get connection even after the completion of the project.

d. provide a crystal clear information that what is going inside PGCIL with respect to RGGVY scheme.
