Point wise reply of the queries is given below:

Query:

Majority of POWERGRID's procurement involves project/turnkey procurement on single source responsibility basis for extra high voltage (EHV) transmission system of 400kV and above voltage level. Item-wise procurement of materials is, generally, not carried out. The total value of procurement during FY 2013-14 has been around Rs 12,237Cr. It may be mentioned that hardly any EHV equipment (viz. Insulators, Transformers, Reactors, Circuit Breakers and Gas Insulated Switchgear etc.) is being manufactured by Micro & Small Enterprises (MSE). However, number of sub-vendors/sub-suppliers under MSE category have been approved by POWERGRID from whom contractor(s) of POWERGRID source component/materials for the main equipment or completed equipment. Considering that the main contractor of POWERGRID may procure such items from MSEs, the procurement by POWERGRID is thus deemed to be meeting the objectives of subject policy. There is no separate breakdown available to enumerate the percentage of supplies from MSE vendors procured by different contractors, which are utilized in any contract.

Besides, there are some small value procurements for Electrical/Civil maintenance items, material for O&M of Transmission Lines/Substations, office equipment/stationary etc. for which tenders are invited from POWERGRID's Regional Head Quarters (RHQs)/departments and other procurement centers. In such type of procurements, the participating MSE vendors have been awarded contracts by various RHQs/procurement centers of POWERGRID. The details of total procurement from MSME vendors have been compiled from Financial Year (FY) 2013-14 onwards and same is available as under:

Further, efforts are being made to put in place system to capture the volume of procurement from MSEs by the main contractors.

Items procured during FY 2014-15 shall be made available after end of FY i.e. 31st March 2015.
