1.	<b>Information sought</b>	I would like to know the last rank holder in all categories who were selected as Executive Trainees (Electrical) through GATE 2014.
	<b>Reply</b>	<p>During the recruitment for the post of Executive Trainee (Electrical) -19<sup>th</sup> Batch through GATE 2014, only the marks obtained by the applicants (out of 100) in the GATE examination were a part of the selection process and no GATE rankings were used.</p> <p>The same had also been notified in the detailed notification dated 3<sup>rd</sup> January 2014 as follows:</p> <p>“The Selection Process consists of marks obtained (out of 100) in the EE paper of GATE - 2014, Group Discussion &amp; Personal Interview.”</p> <p>In view of the above, data pertaining to rank of the selected candidates is not maintained by POWERGRID and hence cannot be provided under the RTI Act 2005.</p>
