
Sir,

1. Kindly provide information regarding the postings/ transfer on loan basis of the Engineers, Secretaries, Sr. Private Secretaries, Executive Private Secretaries and Executives who are the permanent officers of the Power Grid Corporation of India Ltd. (PGCIL) but as on date have been posted outside PGCIL except on deputation basis in any Public Sector Undertaking (PSU), Government Department/statutory body/autonomous body etc., date since when they are so posted and the period for which they are on loan basis/transfer on loan.
2. Kindly provide the copy of rules, as indicated in Information Question No.1 above, regarding postings/transfer on loan basis of the officers outside PGCIL, the Authority who nominates such officers of the PGCIL to work outside PGCIL offices i.e. in PSU/statutory body/autonomous body/Government department/Government organizations on loan/transfer on loan basis.
3. Information on the enabling provisions within PGCIL to provide such officers, as indicated above in question 1, i.e. on loan basis, the name of the Competent Authority in the past & in the present who recommended and is recommending such appointments presently outside PGCIL on loan basis/transfer on loan basis.
4. Information may be supplied on the service rules applicable in relation to the officers as indicated in question no.1 above i.e. on loan basis/transfer on loan basis, maximum tenure of such officers on loan basis/transfer on loan basis, their annual assessment & their controlling officer in PGCIL.
5. Supply information in respect of the number of surplus officers, Private Secretaries, Sr. Private Secretaries, Executive Secretaries & Executives in PGCIL as on date.
6. Kindly provide the copy of the term defined as "loan/transfer on loan basis" with respect to the officers of the PGCIL as indicated in question no.1 above to other PSU/Government Department/Ministry/statutory body/autonomous body.
7. Information may be supplied on benefits being received by the Company i.e. PGCIL from the Government department/Statutory Body/Autonomous Body in lieu of providing officers on Loan Basis/Transfer on loan basis.

8. Information may be supplied on total expenses incurred and received by the PGCIL towards providing the services of officers as indicated above in question no.1.
