

HR manual are not published year-wise. Therefore the exact HBA Rules which existed in year 1998 is difficult to provide. However a copy of the POWERGRID HBA Policy which was last published in year-2002 is enclosed. Important circulars & IOM (amendments) issued from time to time between years-1998 till 2002 are also enclosed which are as follows:
