Against the aforesaid vacancy, total no. of applications received from Persons with Disability = 2 (HH)  Apart from above, 9 persons with disability (OH category) had also applied.

	<b>Reply</b>	Application of Sh Bhagwat Sharma, Regn. ID- 1000249 was received for the post of Sr . Engr.-Electrical. Sh. Sharma, belongs to PwD : OH-OL category, for which post was not reserved. Hence application was not considered against PwD reservation.  The application of Sh Sharma was rejected on following grounds on preliminary scrutiny : 1- In complete Application 2- No proof or supportive documents submitted in support of minimum 3 years relevant experience in relevant pay scale or equivalent level as specified in the advertisement 3- Total post qualification experience is less than 6 years i.e. about 4 years 10 months (training period excluded as advertised).
