Please refer to your application dated 28th February 2014 transferred under section 6(3) of the RTI Act 2005 to this office by Sri I P Nagpal, Under Secretary to the Govt. of India, Ministry of Coal, New Delhi vide letter no. A-60011/7/2005-Coord dated 3rd July 2014 received in this office on 8th July 2014 seeking information under Right to Information Act 2005 which was acknowledged and forwarded to the concerned department vide our letter no. CIL/C-5C/P90/14-15/F-2841/669 dated 9/10th July 2014.

Concerned department on 16th July 2014 received in this office on 17th July 2014 has furnished the following information:

So far as reply pertaining to CIL is concerned, it is stated that due to non-availability of space in the department, the documents upto 2012 have been kept in the Record Room which could not be retrieved. However, for the period 2013-14, approx. 122 letters written by different MPs are available in the department and photocopy of the same can be given to the applicant after getting necessary charges.

Thus you are requested to make arrangement to deposit Rs. 244/- (Rs. 2/- X 122 pages) either by Cash or by DD/IPO/Bankers Cheque in favour of Coal India Limited payable at Kolkata. On receipt of the same the documents shall be furnished to you.

It may also be recalled that the information sought by you is related to CIL and as well as Subsidiary companies of CIL and thus the above application was transferred under section 6(3) of the RTI Act 2005 to PIOs of Subsidiary companies vide our letter no. 669 dated 9/10th July 2014. You are requested to follow up the matter with them.
