Information requested in Letter dated 20/03/2015 from Sh. V.K.Gaur is as follows:

**Representation dated 31.07.2013** was never received in this Office through proper channel. Moreover, it is not possible to entertain all such representations sent directly to Corporate Office unless they are forwarded through proper channel as the same will have inputs from the concerned Site/Region. Nevertheless, the various issues raised by Sh.Gaur have already been addressed at various points in time and a gist of the same is given below;

Sh.Gaur's request for transfer as well as the various VIP references received in this matter, replies were already given expressing our inability to consider the transfer of Sh.Gaur due to manpower constraints.

Further, Sh.Gaur has claimed that his dependant family members require his presence due to their medical conditions. In order to mitigate his problem, family retention permission has already been granted, so that they can avail medical facility at the place of their residence.

All the issues/concerns of Sh.Gaur have been addressed from time to time and nothing is pending at Corporate Office. However, if he still has any grievances left then he may take up the same with the concerned HR Department at the Region where he is posted.
