Q.2 Please provide certified copies of marks obtained along with answer sheets by successful candidates of NR-II in the interview proceedings of 2000 for the Executive cadre of E1.

Reply. CIC decision dated February 10<sup>th</sup>, 2006 states that "in case of evaluated answer sheets, the information available with the public authority is in his fiduciary relationship, the disclosure of which is exempt under Section 8(1)(e) of the RTI Act, 2005. In addition, when a candidate seeks for a copy of evaluated answer paper, either of his/her or others, it is purely a personal information, the disclosure of which has no relation to any public interest or activity, which of such a situation is covered under Section 8(1)(j) of the Act.". Accordingly, the same is not being provided.

Q.3 Please provide certified copies of DPC proceedings for promotion from E1 to E2 in the year 2010 & E2A to E3 in the year 2015 of NR-II.

Reply. Delhi High Court, in its udgement dated 8<sup>th</sup> July, 2014 has held that DPC proceedings are confidential in nature and constitute third party information. Accordingly this information has not been disclosed as it is confidential and personal information and the same has been exempted from disclosure under Section 8(1)(e) and 8(1)(j) of the RTI Act, 2005.
