## **ORDER**

## **Grounds of Appeal**

The Appellate Authority, Corporate Centre, POWERGRID has received an appeal dated 24<sup>th</sup> June, 2015 from Shri Hirak Roy, Emp No. 02450, SRLDC, Bangalore under RTI Act, 2005. Earlier, an application dated 12<sup>th</sup> May, 2015 was filed by the applicant with the CPIO, Corporate Centre, POWERGRID, Gurgaon, under RTI Act, 2005 to obtain following information:

- (i) Photocopy of Performance Appraisal rating/reports for the years 2011, 2012, 2013 and 2014 alongwith photocopy of Reporting/Review officer and Accepting Authority for the Performance Appraisal report for the years 2011, 2012, 2013 and 2014.
- (ii) Total marks under various heads separately and the CPC marks of CPC 2015.

On receipt of the appeal, comments/opinion of the CPIO, Corporate Centre and General Manager (HR) were sought and relevant papers perused. CPIO, Corporate Centre stated that on receipt of the RTI request, the desired information was sought from concerned department. Based on the inputs from concerned department, the applicant vide letter dated 15<sup>th</sup> June, 2015 was advised for inspection of his Appraisal reports for the years 2011, 2012, 2013 & 2014. However, the applicant neither inform nor visit for inspection of documents. There is no denial of information.

With regard to Performance Appraisal rating/reports for the years 2011, 2012, 2013, 2014 and marks in the CPC 2015, General Manager (HR) stated that keeping in view of the confidential nature of the requested information and the applicant being an employee of POWERGRID, applicant was offered for inspection of documents, however, he did not turn up for inspection. Therefore, the applicant is once again advised for inspection of records wherein he would be shown his marks for appraisal reports for the years 2011, 2012, 2013, 2014 and CPC 2015.

Decision: After going through the appeal and the submissions made by the CPIO and General Manager (HR), considering the confidential nature of information the applicant has been advised for inspection of his appraisal reports. However, the appellant neither inform nor visit for inspection and as such there is no denial of information. The appellant is advised for inspection of documents as suggested by the GM (HR)/ CPIO, CC as per the provisions of the RTI Act, 2005.

As no application fee is required for appeals under RTI Act, 2005, IPO of Rs. 10 submitted alongwith the appeal is being returned to the Appellant.

The appeal is accordingly disposed off.
