- 1) Please intimate that misleading information, as communicated vide letter no. C/HR/APP/50890 Dt. 23.12.2005 was due to misinterpretation of the Rule/content of my husband application or deliberate, since such letters are being issued after due consent/vetting of higher authorities.

Reply. The applicant has quoted HR policy manual clause 7.3.3, DoPT, Government of India OM dtd, 28.3.2000 and has reproduced the contents of letter dtd. 23.12.2005 which is a reply to his application dtd. 15.10.2005. The reply to the application of Sh. PK Sharma dtd. 15.10.2005 has been appropriately replied by the corporation as per rules in 2005. Accordingly, there was no misleading information provided to him.

Further, opinion/justification with respect to DoPT OM dtd. 28.3.2000 and HR policy manual clause 7.3.3 does not fall under the definition of information. Hence, no document is being provided.
