1	Information sought	Name and designation of concerned authority who has power to approve or decline the case of appointment on compassionate grounds at the last stage in PGCIL
	Reply	Chairman and Managing Director is the Competent Authority for approving matters pertaining to Compassionate Appointment within the extant rules.
2	Information sought	As per PGCIL recruitment policy and procedure under para 20.0 and sub-clause 20.1 defined "In the case of any doubts arising with regard to any of the provisions in the Recruitment Policy and Procedures and in the cases not covered by these rules, final authority of interpretation will vest in the Chairman and Managing Director whose decision will be final". As well as letter issued to Mrs. Nisha Gupta dated 19 th Dec 2013 in reply to her RTI request by Corporate Center vide no. CP/RTI/2013/134 clearly mentioned in point (2) that "Chairman & Managing Director, POWERGRID is the Competent Authority for approving or declining cases for appointment on compassionate ground." From the above, if the final decision vest in the CMD of PGCIL in all cases of recruitment on compassionate grounds then supply the copy of the following: A) Certified copy of proper channel in which POWERGRID Patiala S/s personnel department send the copy of representation in Feb 2010 filed by myself in respect of Compassionate Appointment in case of my Late father Sh. Ranjit Singh to Jammu RHQ and Jammu RHQ dispatch the same copy to CMD office for the purpose of approval or disapproval of the said case as per PGCIL recruitment policy which was also followed in Late Sh. Rakesh Gupta case
	Reply	A) Information pertains to NRTS II and same will be provided by CPIO, NRTS-II directly to you.
В	Information sought	The copy of signed disapproval letter by Competent Authority was also supplied to Late Mr. Rakesh Gupta's wife Mrs. Nisha Gupta in year 2012 and 2013. So it is requested to provide the same procedural copy marked by officials of Patiala GHQ, Jammu RHQ and CMD along with other officials at Corporate Center to be of Feb 2010.
	Reply	B) A) Information pertains to NRTS II and same will be provided by CPIO, NRTS-II directly to you.
С	Information sought	Certified copies of reasons recorded on notesheet showing disapproval of the Competent Authority, i.e. CMD in my case of Compassionate ground in respect of my father Late Sh. Ranjit Singh. As the same copy was also provided by PGCIL to Mrs. Nisha Gupta w/o Late Sh. Rakesh Gupta vide letter dated 19.11.2012 and 19.12.2012 signed by CMD, Dir (Pers), ED (HR), AGM (HR-Estb), AGM (HR), CM (HR)
	Reply	As mentioned in the reply to Query No. 1, Chairman and Managing Director is the Competent Authority for approving matters pertaining to Compassionate Appointment within the extant rules. However, any representation is forwarded up in the channel based on its merit. The case of providing compassionate employment to Sh. Jatinder Singh clearly does not fall under the extant rules of the organization since his father, Late Sh. Ranjit Singh died due to illness rather than due to accident while on duty.
