Subject: Request for information under RTI-Act-2005.

With due respect, myself Jatinder Singh s/o Late S. Ranjit Singh resident of Samrala (Punjab) requested you to provide following informations as per RTI-Act-2005.

- ① Name and designation of concerned authority, who has power to approve or decline the case of appointment on compassionate grounds at the last stage in PRCIL.
- ② As per PRCIL recruitment policy and procedure under paragraph 20.0 with a sub-clause added vide point 20.1 defined "In the case of any doubts arising with regard to any of the provisions in the Recruitment policy and procedure and in the cases not covered by these rules, final authority of Interpretation will vest in the chairman and managing director whose decision will be the final". As well as letter issued to Mrs. Nisha Gupta on dated 19<sup>th</sup> Dec-2013 in reply of her RTI request by corporate center vide no: CP/RTI/2013/134 clearly mentioned in point (2) that "Chairman & managing director, PowerGRID is the competent authority for approving or declining cases for appointment on compassionate ground."
