

Point wise reply to the information sought by the applicant by Shri Zishan Ahmad under RTI Act, 2005 vide his application dated 15.06.2015 under RTI Act, 2005.

1.0	यह कि प्रार्थी दिनांक 30.01.2015 को फाउन्डेशन कार्य मानक के अनुरूप नहीं हुआ है आवश्यक जाँच हेतु एक प्रार्थना पत्र शपथ पत्र सहित दिया था पत्र की फोटो कांपी संलग्न है। जाँच में क्या पाया इसकी ब्योरेवार सूचना दें।	After receipt of the complaint, an inspection was conducted at site in Unchahar (Raebareilly) to verify the facts by a committee. However, the allegations made in the said complaint were found baseless during verification / inspection.
2.0	यह है कि जब तक जाँच नहीं मानी जाती जब तक शिकायकर्ता के हस्ताक्षर करके शिकायत की पुष्टि ना करा ले अपने शिकायकर्ता के हस्ताक्षर करा कर पुष्टि की या नहीं ब्योरेवार सूचना दें।	The complainant, before this complaint has made two different complaints which had already been verified under the signatures of the complainant. As signatures of Sh. Zishan Ahmad on the complaint in question was same as on the other two complaints and address and mobile number mentioned in the said complaints were also same. The signature on this complaint was also tallying with his signature taken during verification by earlier complaint. Accordingly, it was considered not necessary to take signature of the complainant in this case as there was no doubt about the genuineness of the complaint.
3.0	यह कि जिन अधिकारियों ने उंचाहार जाकर जांच की तो उन अधिकारियों के पद नाम सहित की ब्योरेवार सूचना दें।	The name of Investigating Officers may not be disclosed as it may endanger the life / physical safety of person. As such we may claim exemption under Clause 8 (1)(g) of RTI Act, 2005.
