**Respected CPIO,**

Myself Jatinder Singh resident of Samrala (Punjab) here requested you to provide following information's as under:-

1. Total amount in Indian Rupees paid to Amity international School Gurgaon Sector-43, and Gurgaon Sector-46 as a charity or sponsorship or as donation or in any other way since FY-2005 to FY-2015.
2. Under which provisions Mrs. Neetu Singh w/o Late Sh Bharat Kumar Employee number 01262 (Deputy Manager) Allotted a power grid quarter in Gurgaon Sector-46 while presently she is working as a teacher in Amity school Gurgaon sector-43.
3. From the above the facts and circumstances corroborating that Mrs. Neetu Singh and her family completely living under shelter of powergrid by back door entry or by favourism. Employment provided to her in Amity school cannot be co-incident just because she is living in Powergrid Apartments while she is permanent resident of Distt Chandauli Distt. U.P.
4. What are Relationship of Former Power Grid chairman and Managing Director Mr. R.P Singh with the family of Late Mr. Bharat Kumar and family. Name of officer of power grid who refer or suggest Mrs. Neetu Singh to join Amity School along with officer who sanction power grid accommodation to her.
5. What is status of Mrs. Jyoti Mishra w/o Late Sh Ajeet Kumar Mishra (JE-Gr-III). As the fatal road accident near Gwalior on dated 29.06.2012 consists both these employees died in same manner. Whether she offered apartment for residence in Power grid Gurgaon Sector-46 Just like Mrs. Neetu Singh. If not please specify the reasons.
6. How many rent paid by Mrs. Neetu Singh per month for her apartment in which her family residing at Gurgaon Power Grid colony Sector-46. If rent is concessional to her then supply the provisions under which she get concessions. As she is reportedly only one who was dependent of power grid employee and residing in power grid apartment.
7. How many dependents of powergrid expired employees who allotted the accommodation in power grid Gurgaon Sector - 46 residential complex. Kindly specify the rules under which only amity school staff can eligible to allot power grid apartment.
8. Total Terminal Benefits paid in lieu of Mr Bharat kumar to his dependents except monthly pension of Rs.4818/-.
