

1	<p>Mr S K Chauhan SSG,Dadri (emp.no.10258) has sought reply that he did not get chance to attend Next Innings training program meant for employees who are superannuating .He got superannuated on 31 July 2015.</p>	<p>Corporate HRD organizes Next Innings program for all categories of employees. During 2014-15 Corporate HRD organized 4 Next Innings training programs for Executives (one program) , Supervisors (one program) and Workmen (2 program). The employees are nominated on basis of batch size, suitability and work assignments. During 2014-15 a total of 85 executives superannuated &37 attended, 43 supervisors superannuated &19 attended and 62 workmen superannuated & 26 attended. In the instant case since the batch size was large therefore all the employees were not nominated . It is not mandatory to attend the program. However a large number of employees are given chance to attend.</p>
