Subject: Application (2nd) under Right to Information Act 2005, for providing the following information & documents.

Sir,

- 1. The applicant being a citizen of India is desirous of obtaining the following information and documents under the R.T.I. 2005.
 - (1) Certified / attested copy of the license given u/s 68 of the Electricity Act 2003 to Parbati Kol Dam Transmission Company Ltd. having its corporate office at 3rd Floor Building No. 20, Nehru Palace, New Delhi, for inter-State transmission line.
 - (2) Whether Parbati Kol Dam Transmission Company Ltd. the licensee to whom approval / license is granted subject to compliance of the requirement of the provisions of Electricity Act 2003 and also the Rules made thereunder can carry out the work of transmission of electricity lines including that of erecting the towers without complying with the provisions of Electricity Act 2003 and also the Rules made thereunder?
 - (3) Whether the non compliance of the provisions of Electricity Act and also the Rules made thereunder by Parbati Kol Dam Transmission Company Ltd. entails the forfeiture of the license or not?
 - (4) Whether Parbati Kol Dam Transmission Company Ltd. has submitted any documentary proof showing that in compliance of the Electricity Act & Works of Licensees Rules 2006 made thereunder, prior consent of the land owner has been obtained while laying the transmission lines & towers etc.?

- (5) Kindly also supply a certified copy of the license no. 5 / transmission / CER dated 15.9.2008 issued by Central Electricity Regulatory Commission in favour of Parbati Kol Dam Transmission Company Ltd.
- (6) Whether Parbati Kol Dam Transmission Company Ltd. can say that since it has been granted power under the Telegraph Act 1885, so the compliance of the provision of Electricity Act and also the works of licensees Rules 2006 is not required to be done by Parbati Kol Dam Transmission Company Ltd. whereas under the license issued by Ministry of Power, it subject to compliance by is necessary and mandatory for Parbati Kol Dam Transmission Company Ltd. to the provisions of Electricity Act and the works of licensees rules 2006?
- (7) Parbati Kol Dam Transmission Company Ltd. can claim it as Govt. company and dictates it terms upon DC, SDM, Tehsildar and Police Authority in order to pressurize the land owners for permitting it to erect the tower and lay the transmission lines.
- (8) Kindly supply a copy of the guidelines and instructions which are required to be complied with by Parbati Kol Dam Transmission Company Ltd. while erecting towers and laying the electricity lines.
- (9) Kindly supply the drawings cum taining the specifications of the transmission towers and lines which shall be erected and laid by Parbati Kol Dam Transmission Company Ltd. under the license issued by Ministry of Power.
- (10) Kindly also supply the information as to how much area in meters on both the sides of transmission towers and electricity lines going to be laid and erected by Parbati Kol Dam Transmission Company Ltd. under the license issued by Ministry of Power cannot be cultivated by the landowners on both the sides of such tower / transmission lines.
- (11) Whether the landowner through whose land such transmission lines and tower etc. are going to be laid and erected can object and protest against the constant humming noise pollution of highest degree caused on account of transmission line?

- That on an earlier occasion a similar application under RTI Act was sent but vide your letter no. 10/6/2014 – RTI dated 25.6.2014, the same has been returned with the observation that the amount of Rs. 10/- be sent through Indian Postal Order payable to the Accounts Officer, Ministry of Power. The earlier Indian Postal order of 100/- sent has also been returned
- That accordingly, the application is resubmitted alongwith postal order of Rs. 10/- issued in favour of "Accounts Officer, Ministry of Power".

It is, thus, requested that the aforementioned documents / information may kindly be supplied to the applicant / undersigned at the earliest, keeping in view the intent and scope of R.T.1. Act 2005.
