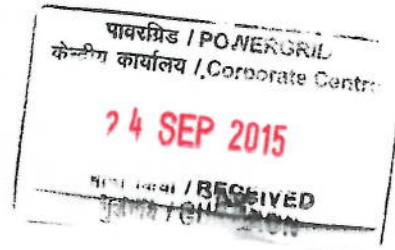


This is with reference to your letter No. FNo.PIO/R/1415/475 dated 10.03.2015. This information is sought under RTI Act 2005.
