We, the above mentioned staff, express our expressions of anxiety on a subordinate Grade employee like Sh. Anil Kataria and officers, degradation under negligible treatment and ill-treatment on SC/ST employees in POWERGRID for mistreating their fellow employees.

It is requested to study cause necessary action on the above circumstances mentioned with Sh. Anil Kataria as per POWERGRID CEA Rules, as well as under the provisions for protection of abuses on SC/ST employees.
