In this regard, it is stated that Establishment (Reservation) Section mainly deals with the policy of reservation for persons with disabilities and ex-servicemen in the posts/services under the central Government. Reservation-II Section also maintains data on representation of SCs, STs and OBCs in Central Government Ministries/Departments. This Section does not maintain any data on community-wise break up among OBCs.
