Supply the copy of total amount in Rupees collected on that score. How much amount was distributed among both deceased family dependents Under which provisions this circular issued within department. For how many expired employees this type of appeals circulated in powergrid. 5.Your reply of Para 3 that the contents of this paragraph is vague and imaginary is neither fair nor rightly stated. A sufficient ground was established that suddenly a family of powergrid expired employee still remained and resided at powergrid complex 		

at different stations i.e from Western region-II to Corporate center (Late Mr. Bharat kumar family). This is possible only due to high influential power. Although Smt neetu singh w/o Late Sh. Bharat kumar a needy but there are many more. Despite Total terminal benefits received by the family of Late Bhurat kumar was more than 1 crore rupees.
