Query: Kindly provide information on SMART GRID projects in India which are completed or under completion and total amount spend on each project (in INR) till 30-September-2015.

Reply:

Ministry of Power, Government of India had sanctioned fourteen (14) Smart Grid Pilot Projects in August 2012 and one (1) Smart City Pilot Project in July 2014 at various geographical locations in the country. Details of these pilot projects are available at http://nsgm.gov.in/content/sg_pilots.php for public use.

Till September 2015, MoP had disbursed Rs.11.19 Crores for projects at CESC (Mysore) [Rs.4.07 Crores], HPSEB (Himachal Pradesh) [Rs.2.43 Crores] and IIT Kanpur (Smart City Project) [Rs.4.69 Crores].
