This may be given Top Priority looking into the provisions of RTI Act, 2005.

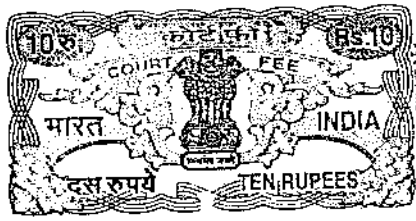

Read: Memorandum No. 5/23/77-PER (B) dated 31-7-2015. On the recommendation of Goa Public Service Commission vide their letter No. COM/II/4/16(1)/08/1125 dated 21-07-2015, the Governor of Goa is pleased to appoint Shri Dipak S. Bhajekar, Additional General Manager, WRTS-II, Power Grid Corporation of India Limited, Gurgaon to the post of Chief Electrical Engineer, Electricity Department, Government of Goa, Panaji by transfer on deputation initially for a period of 2(two) years subject to the following conditions.

1. He should go under medical test for fitness purpose.
2. Other terms and conditions shall be decided in the due course of time.

I am In a process of Filing Public interest Litigation in the hon'ble High Court Of Bombay at Goa about the illegal appointment of the Chief Electrical Engineer by protecting his pay of Semi Government depar when actually he was deputed to the PGCL from Central Government on political pressure to sell Electricity Department of Goa to TATA. I am hereby requesting you to give the information under the RTI Act as below-
