

This has reference to your letter dated 26th January, 2016 in responce to POWERGRID letter dated 22<sup>nd</sup> January, 2016, regarding information sought by Shri Amardeep Singh under RTI Act, 2005.

As the information sought was related to Financial/Technical bids of a third pary, in line with Section-II (1) of the RTI Act, 2005, a written notice was issued to M/s GeoDigital seeking consent for disclosure of the information. Wherein, vide letter dated 26th January, 2016 M/s GeoDigital have objected for disclosure of the requisite information under section 8(1)(d) of the RTI Act, 2005 stating that information sought is proprietary and commercially sensitive to GeoDigital. M/s. GeoDigital also stated that in the event POWERGRID intend to disclose the information, same may be shared with M/s GeoDigital before disclosure so that same can be assessed at our end.

POWERGRID is intending to provide the information to the applicant regarding the prices quoted under three options as attached at Annex-I. The disclosure of above information is also in line with the decision dated 1st September, 2014 of the Hon'ble Central Information Commission, in similar case of disclosure of third party information.

In view of the above, it is requested to convey your confirmation for disclosure of the information (i.e prices quoted under three options) as attached at Annex-I, at the earliest, not later than 10 days of this letter. Your co-operation in confirming the above for providing the information to the requestor is solicited, please
