

In case the implementation has not yet been completed, please advise me of the plans for its implementation.
2. CVC vide its Circular No 17/07/09 issued under ref. no. 005/VGL/4 dated 14.07.09 had directed ensuring posting of details of tenders on websites. Kindly confirm that your Ministry / Department and Undertaking have already implemented the guidelines as per the directions of CVC. In case it has not yet been implemented till now please let me know what is your programme for its implementation.
