1. The power transfer level from rectifier to inverter station for newly commissioned multi-terminal HVDC BNC Agra Project is 3000 MW.
2. Equipment monitoring period starts after 06 (SIX) months of successful completion of trial operation. Thereafter, Equipment Failure Rate is computed over a period of 01 (ONE) year. Hence, rate of failure is not computed.
3. There is no equipment failure at Agra end. However, at BNC end 01(ONE) No. single-phase converter transformer bushing unit of 800kV DC Class failed for converter transformer of Pole-I.
