Subject: Request for certain information under Right to Information (RTI) Act 2005 – First Appeal- Regarding

In my RTI Application (PGCIL/R/2016/50052), I had requested the certified copy of the legal opinion given by Attorney General of India to Power Grid Corporation of India Limited.

But the concerned CPIO have refused to provide the requested information stating that, the legal opinion given by a lawyer to his client, is a confidential information on account of the fiduciary relationship between the lawyer and client and so the sought information is exempted from disclosure under Section 8(1) (e) of the RTI Act.

As the above reply given by the CPIO through Letter No.CP/RTI/2015/330, dated 18.04.2016 (Attached for your reference), is not satisfactory, I hereby appeal to you with the following grounds.

Grounds of the Appeal:

- 1. First of all, the legal opinion is supplied by the honorable Attorney General of India, in his official capacity as Chief legal adviser to the Government of India and not as a private lawyer. So, his opinion gets public importance and has to be published.
- 2. Even the client i.e. Power Grid Corporation of India Limited, is a Government of India Enterprise/ Central Public Sector Undertaking/ Central Transmission Utility, wherein the Government of India have major shareholding. Considering the role of the government of India which is for the welfare of all the peoples in India, I believe the Power Grid Corporation of India Limited, is also working for the public cause having larger public interest, more than the commercial/private interest. So, the Power Grid Corporation of India Limited, being a public authority, has to provide the requested information considering the larger public interest in disclosing such information.
- 3. Moreover, the subject matter for which the legal opinion is obtained is about a matter affecting the interest of the public at large. The Right of Way issue in the laying of Transmission line is going on throughout India, affecting lakhs & crores of farmers/land owners and the opinion given by the honorable Attorney General of India is almost similar to the earlier decisions of many High Court and Supreme Court cases. So, this legal opinion that recommends providing compensation for the land used for the laying of transmission line is no more a secret and is not at all confidential information that needs to be protected from disclosure.
- 4. Even if the legal opinion which I have requested is an information available with the client in a fiduciary relationship, Section 8(1) (e) of the RTI Act 2005 mandates to disclose even those information, if larger public interest warrants to disclose it.
- 5. Further, the Right to Information Act 2005, having its main objective to bring in transparency and accountability in the working of every public authority and in view of section 4(1-c,d) of RTI Act 2005, which says every public authority has to publish all relevant facts while formulating important policies or announcing the decisions which affect public and every public authority has to provide reasons for its administrative or quasi-judicial decisions affecting public, it is very much essential to provide the information requested in my RTI Application.

Prayer:

In view of the above facts and grounds of this case, I humbly pray to you, to provide the requested information at the earliest.
