

AGREEMENT

BETWEEN

NATIONAL HYDROELECTRIC POWER CORPORATION LTD.

POWER GRID CORPORATION OF INDIA LTD.

THIS AGREEMENT entered into on the 22nd day of July Two Thousand Five(.22. 07.:2005) between National Hydroclectric Power Corporation Ltd., a Company incorporated under the Companies Act, 1956 having its registered office at NHPC Office Complex, Sector-33, Faridabad-121003(Haryana), a generating company involved in establishment, operation and maintenance of the generating station under Electricity Act 2003 (hereinafter called "NHPC" which expression shall unless repugnant to the context or meaning thereof include its successors and assigns) as party of the first part and Power Grid Corporation of India Ltd., a Company incorporated under the Companies Act, 1956 having its Registered office at B-9, Qutab Institutional Area, Katwaria Sarai, NEW DELHI-110 016 a transmission company and CTU involved in establishment, operation and maintenance of the transmission system under Electricity Act 2003 (hereinafter called "POWERGRID" expression shall unless repugnant to the context or meaning thereof include its successors and assigns) as party of the second part.

PREAMBLE

WHEREAS' NHPC has been established by Govt. of India with an objective to establish, own, operate and maintain hydro-electric power stations and NHPC is desirous to establish various Hydro-electric stations to be owned and operated by it (hereinafter called as generating units) as detailed in the Annexure to be annexed here to in terms of clause 1(a) below forming integral part of the Agreement :



AND WHEREAS the power from various hydro-electric power stations to be established by NHPC needs to be evacuated to different regions of the country through the Associated Transmission System ATS...

AND WHEREAS POWERGRID is responsible for setting up associated transmission system (hereinafter called as "ATS" as detailed in the Annexure to be annexed forming integral part of the Agreement) for evacuation of power from the above projects in integration with the existing transmission system The ATS shall be inter-alia used by POWERGRID to evacuate power from concerned generating units. The ATS will be used by POWERGRID to evacuate power from concerned NHPC power stations as a first right. The utilization of ATS shall be governed by the Electricity Act 2003.

AND WHEREAS both NHPC and POWERGRID are desirous to match the commissioning schedule of the generating units vis-a-vis the associated transmission system.

NOW THEREFORE, in consideration of the premises and mutual agreements, covenants and conditions set forth herein, it is hereby agreed by and between the parties as follows:

1. SCHEDULE OF COMMISSIONING

a) The Schedule of Commissioning of generating units alongwith the ATS (the zero date from which the indemnification mechanism shall be applicable) shall be worked out for each generating units vis a vis ATS and mutually agreed in the Quarterly Director level coordination meeting between POWERGRID and NHPC within 3 months of investment approval which will form an integral part of this Agreement. The above schedule for the generating units and the ATS shall be regularly reviewed in the Quarterly Director level coordination meeting between NHPC and POWERGRID. O su Meugh

b) A Co-ordination Committee Consisting of 2 (two) officials of NHPC and 2 (two) officials of POWERGRID shall be constituted within 2 weeks of signing of this Agreement, which shall regularly monitor the progress of the system on quarterly basis.

1. 2. INDEMNIFICATION

- a) In the event of delay in commissioning of generating units vis a vis ATS the defaulting party shall pay the Interest During Construction (IDC) including Foreign Exchange Rate Variation (FERV) and Govt. Guarantee fee if any for generating units and ATS calculated as lower of the two, up to a period of six months form the zero date. However, the defaulting party shall pay the indemnification claim only in case of revenue loss or part thereof suffered by the other party due to delay in commissioning by the defaulting party.
- b) Either party who was ready to commission and have notified the other party, shall obtain a certificate from Statutory Auditors at the end of financial year certifying the amount of IDC from zero date to actual date of commissioning or six months IDC whichever is less.

3. BILLING AND PAYMENT

- a) The quantum of IDC including FERV and Govt. Guarantee fee if any payable shall be worked out based on the audited expenditure of the commissioned Generating units or ATS as the case may be.
- b) Either party shall present a bill for the amount of IDC including FERV and Govt. Guarantee fee if any to the other party, at the end of the indemnification period. The amount of IDC including FERV and Govt. Guarantee fee if any will be paid within 10 days of presentation of bills by either party to the other party.

4. <u>LIMITATION OF PAYMENT</u>

No claim other than IDC including FERV and Govt. Guarantee fee if any referred to above i.e. any indirect loss due to delay in commissioning Generating Unit/ATS shall be payable by either party to other party.

SURCHARGE

In case payment is made after the due date by either party, the surcharge @ 15% per annum shall be charged on the amounts remaining unpaid after the said date in proportion to the number of days of delay after the said date.

6. ARBITRATION

- 6.1 All differences and/or disputes between the parties arising out of or in connection with these presents shall at the first instance be settled through amicable settlement at the level of Chief Executive.
- 6.2 In the event of unresolved disputes/differences, the same shall be settled through Arbitration as per provision contained in Govt. of India, Ministry of Industry Office Memorandum No. DPE/4/2001-PMA-GLI dated 22/1/04. The relevant provision reads as under;-

"In the event of any dispute or difference relating to the interpretation, and application of the provisions of the contracts, such dispute or difference shall be referred by either party to the arbitration to one of the Arbitrators in the Department of Public Enterprises to be nominated by the Secretary to the Government of India, in charge of Bureau of Public Enterprises. Arbitration and Conciliation Act, 1996 shall not be applicable to the arbitration under this clause. The award of the Arbitrator shall be binding upon the parties to the dispute, provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Department of Legal Affairs, Ministry of Law & Justice. Government of India. Upon such reference the dispute shall be decided by the Law Secretary or the Special Secretary/Additional Secretary when so authorized by the Law Scerctary, whose decision shall bind the parties finally and conclusively. The parties in the dispute will share equally the cost of arbitration as intimated by the Arbitrator."

- 6.3 The Arbitrator with the consent of the parties may enlarge the time, from time to time, to make and publish the award. The Arbitrator shall give reasoned and speaking award. The venue of the Arbitration shall be New Delhi. The Courts of Delhi shall have exclusive jurisdiction.
- 6.4 Notwithstanding the existence of any disputes and differences referred to arbitration, the parties herein shall continue to perform their respective obligations under this Agreement.

7. FORCE MAJEURE

No party shall be liable for any claim for the default or delay due to force majeure event such as riot/strike (other than among the employees

of POWERGRID/NHPC), lock-out, Civil commotion (to the extent not insurable), war(whether declared or not), invasion, Act of foreign enemies, hostilities, civil war, rebellion, mutiny, revolution, insurrection, military or usurped power, damage from aircraft, nuclear fission, forces of nature, accident, acts of God such as earthquake(having magnitude more than the design coefficient), lightening, unprecedented floods, geological surprises and other such eauses over which POWERGRID/NHPC has no control. But any party claiming the benefit of this clause shall satisfy the other party of the existence of such an event and give written notice within a reasonable time to the other parties to this effect.

8. EFFECTIVE DATE AND DURATION OF AGREEMENT

This Agreement shall be deemed to have come into force with effect from the date of signing of this Agreement for all purposes and intent shall remain operative till the settlement of claim of either side under the Agreement.

9. NOTICE

All notices required or referred to under this Agreement shall be in writing and signed by the respective authorized signatories of the parties mentioned herein unless otherwise notified. Each such notice shall be deemed to have been duly given if delivered or served by registered mail/speed post of Department of Post with an acknowledgement due to other party (ies) as per authorization by the parties.
