Sub: Qualification acquired through distance education Mode- Clarification by All

India Council of Technical Education (AICTE).

Clarification has been sought whether the qualification acquired through distance education mode will be considered by POWERGRID for incentive, promotion purposes etc.

In this regard, please refer to Public Notice (Advt No. UB/03(03)/2010) of All India Council for Technical Education (copy of notification enclosed for reference). The notification clearly states that AICTE does not recognize qualification acquired through distance education mode at Diploma, Bachelors and Masters level in the fields of Engineering, Technology, Architecture, Town Planning, Pharmacy, Hotel Management and Catering Technology, applied Art & Craft and Post Graduate Diploma in Management (PGDM). AICTE has a policy to consider only MBA & MCA through distance mode for its recognition.

Since AICTE does not recognize qualification acquired in above mentioned fields through distance education, the same will also not be considered in POWERGRID for any purpose i.e. Promotion etc. except for incentive under Additional Qualification Incentive Scheme. Further, only those MBA & MCA qualification through distance mode that has been recognized by DEC as well as AICTE will be considered in POWERGRID. However, the cases of employees who had acquired qualification through distance mode which are not recognized by AICTE but have already availed the benefits of promotion etc. will not be reopened.

It has been the policy of the AICTE, not to recognize the qualifications acquired through distance education mode at Diploma, Bachelors & Master's level in the fields of Engineering, Technology, Architecture, Town Planning, Pharmacy, Hotel Management & Catering Technology, Applied Arts & Crafts and Post Graduate Diploma in Management (PGDM). AICTE has the policy to consider only MBA and MCA through distance mode for its recognition. All the existing students / prospective students pursuing/ wanting to pursue any educational programme in the above mentioned fields are hereby advised to check the approval by Joint Committee of DEC, UGC and AICTE on AICTE's webportal at www.aicte-india.org. In the absence of the said approval the MBA & MCA qualifications acquired through distance mode may not be recognized for the purpose of employment under Central Government.

SUB : Qualification acquired through distance education mode-Clarification thereof.

The Hon'ble Supreme Court on 25th April 2013 has passed a judgement in case of Civil Appeal No: 1145 of 2004, Private College Vs All India Council for Technical Education (AICTE) & Ors whereby they have stated that AICTE approval is not required for obtaining permission and running MBA course by private colleges since it did not fall under the definition of "Technical Education".

Therefore, in continuation to our earlier IOM No: 257/2013 dated 22.02.2013 it is informed that approval from the AICTE is not required for obtaining permission and running MBA course by the Private colleges. This decision is subject to further outcome of review petition (if any) filed against the aforesaid judgement dated 25.04.0213 or issuance of any Public/ Press Notification by UGC and/ or AICTE and/or DEC or any clarification (Circular/ Order) of the appropriate Government Authority/ Department in this regard.
