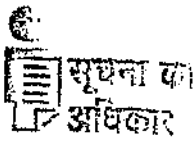

Sir,

Reference is invited to your application dated 25.05.2016 received through transfer from Ministry of Labour & Employment seeking information under the Right to Information Act, 2005. So far as Estt.(Res-II) Section of DoPT is concerned, it collects and maintains data on the representation of Persons with Disabilities in the posts and services under the Central Government as on 1<sup>st</sup> January of each year. In this regard copy of data sheet showing the representation of VH/HH/OH and appointment made during the previous calendar year as on 01.01.2012 to 01.01.2016 as received till date from various Ministries/Departments/Organisations is enclosed.

As regards information about Posts lying vacant for Persons with Disabilities, it is stated that in compliance of the Hon'ble Supreme Court's order, this Department obtained data on vacancies identified for persons with disabilities from all the Ministries/Departments and reported to the Apex Court. As per information received from various Ministries/Departments, 15831 vacancies were identified for persons with disabilities and out of which 11098 have been filled up so far.

However, your RTI application is being transferred to all Ministries/Departments of the Government of India for providing information directly to you.

2. Appeal, if any, in the matter may be preferred to Shri G. Srinivasan, Deputy Secretary, 1<sup>st</sup> Appellate Authority, Department of Personnel & Training, North Block, New Delhi within 30 days from the date of receipt of this communication, if you not satisfied with the reply of the CPIO.
