

Reply:

A letter was received from Ministry of Power; No.C-30019/19/2015-V&S dated 12.08.2015 regarding framing & transfer policy in all cadres. Transfer policy for Executives is under consideration and is in final stage. One clause has been inserted in Transfer Policy which states that preference for request transfer shall also be given to executives having abled/ differently-abled children.
