Dear Ms. Suganya,

This has reference to your online RTI request dated 8th July, 2016 seeking information under RTI Act, 2005.

As the information sought regarding MTOA application was pertaining to third party (M/s Jaiprakash Power Ventures Ltd.), in line with Section-11 (1) of the RTI Act, 2005, written notice was issued to third party seeking consent for disclosure of information. Wherein third party, while giving consent for disclosing of following documents, informed that Power Purchase Agreement (PPA) being a confidential agreement with confidentiality clause, may not be disclosed. Accordingly, related documents are attached, please:

- (i) Duly filled application in specified format.
- (ii) Proof of payment of application fee.
- (iii) Concurrence of LDC/SLDCs as applicable.

With respect to point (ii), it is to mention that payment of application fee is made directly to the POWERGRID account and details of the same are available in the application itself.

Regarding point no (iii), it may be noted that as both injection & drawl points are at ISTS network, NOC from LDC/SLDCs is not required. However, NOC issued by NVVNL (Nodal Agency for transfer of power to Bangladesh) has been submitted along with the application.

Accordingly, copy of Application & NOC issued by NVVNL are attached at Annex-I.
