The scheme for Departmental Examination for acquiring qualification equivalent to Diploma in Engineering prescribed for promotion to Executive category (E1) has been finalised.

The scheme will cover eligible employees working in Technical grades in the Supervisory Grades of S3 (Rs.2075-80-2635-85-3375) and S4 (Rs.2250-85-2930-90-3740) and who do not possess prescribed qualification for promotion to the Executive Cadre i.e. Diploma in Engineering in their respective disciplines. The examination will be conducted in three disciplines viz. Mechanical, Electrical and Civil Engineering. Employees who already possess the prescribed qualification for promotion to the Executive category are not eligible to appear in the examination.

Eligible employees will have to appear in their respective disciplines. The detailed syllabus and recommended readings for the examination are given at Annexure-I. The examinees will appear in two papers which are common for all disciplines (mentioned as 'Common Subjects' in Annexure-I) and all four papers under their respective disciplines (mentioned as 'Specialised Subjects' in Annexure-I).

Eligible employees desirous of appearing for this examination are requested to fill up the prescribed registration form (as enclosed) and submit the same to the concerned Head of Personnel for onward transmission to Corporate Centre. The application forms duly filled in should reach Corporate Personnel Division on or before 30-11-1993.

The examination is proposed to be conducted in the month of January, 1994. The detailed schedule of the examination is being forwarded shortly.

The Scheme will be operated centrally by the Corporate Personnel Division. All other terms & conditions relating to registration, marks, etc., will be same as in the case of Departmental Examinations in the area of Personnel, Finance and Materials.
