I have been given to understand by RECLD that after completion of bidding process the project was transferred to Essel Infrastructure ltd (Essel) and that role of RECTPCL ceases to exist after this transfer. It is the responsibility of Essel to finalize route as per its own

assessment for laying of transmission line and obtain required consents and approvals etc.

Please let me know the following:

1. The name and designation of person from Ministry of Power or its designated Govt. official who gave approval on the cable route.

2. Did this man who approve the route after physically visiting the route site before giving approval or he just approved the route sitting in office.

3. How come this cable route approval was given to run through developing areas of Punjab whereas this cable route should have been away from city / town developments.

4. Name ,designation and contact nos. of person from Govt. office who approved working drawings and co-ordinates of cable route and its towers.

5. I want to know co-ordinates of towers 16 to 20, who can provide me this information.

6. Tower 17 was originally designed to be Angle type B, which later was changed to be type A. Name ,designation and contact nos. of person who made this change and person who approved and passed it from Govt. side.

7. Name, contact and designation of person from Ministry of Power / its designated Govt. office, who is supervising this project to ensure that the cable route, towers and installation work is being carried out as per drawings approved by Govt.
